

Information about the Extraordinary Special Benefit for Child-rearing Households in FY2021

- * The City of Yokkaichi will provide a benefit to support the lives of child-rearing households.
- * Check the following requirements. If you meet them, fill out the application form and submit it to the information desk about the benefit. (The application form, etc. will be posted on the city's website later.)
- * The City of Yokkaichi will send a notice to individuals who are considered to be eligible to receive the benefit in mid-January 2022, together with an application form and a return envelope.

Eligible recipients of the benefit

Eligible recipients

- 1) Recipients of the child allowance for September 2021 (for October 2021 for babies born in September 2021)
- 2) Individuals who are raising children (high school students) (born from April 2, 2003 to April 1, 2006), etc. as of September 30, 2021
- 3) Individuals who are raising babies born from October 1, 2021 to March 31, 2022

Income limit:

Judgement is made based on the income of the main income earner (a guardian whose income is higher than that of the other guardian) in 2020. Recipients of the special benefit for child allowance are ineligible.

Benefit amount

100,000 yen per child*

* The City of Yokkaichi will provide a lump-sum benefit of 100,000 yen in cash.

* Regarding recipients (except public employees) of the child allowance for September 2021, the benefit was provided for children registered by the city without an application on December 27.

How to receive the benefit

- Where to apply: Information Desk about the Extraordinary Benefit for Supporting Lives of Child-rearing Households on the second floor of the city hall
- Application period: Monday, January 17, 2022 to Thursday, March 31, 2022
- Items to be submitted

All applicants

- 1) Application form
- 2) Photocopy of an identification document of the applicant
(e.g., driver's license, health insurance card, My Number Card, pension book, long-term care insurance card, passport)
- 3) Photocopy of a document confirming the financial institution to be used for the transfer (only of the applicant)
(a document confirming the name of the financial institution, account number, and name of the account holder to identify the account to transfer the benefit, such as a bankbook or cash card)

Only relevant applicants:

If an applicant or spouse did not have a resident record in Yokkaichi City as of January 1, 2021

4) Tax certificate of the relevant applicant or spouse for FY2021

If the applicant lives separately from a target child, who has his/her resident record in a municipality other than Yokkaichi City

5) Photocopies of resident records of all the household members, including the target children

* An applicant who lives in a place other than the resident record to avoid violence from the spouse or who is going through a divorce by agreement, etc. may be requested to submit other documents.

• Benefit payment period

The benefit will be transferred to the bank accounts of applicants after screening. (We will start bank transfer in late January.)

FAQs

- Q1. A mother raises a high school student and lives separately from her husband due to going through a divorce by agreement. Who receives the benefit, the mother or her husband?
- A1. If parents are going through a divorce by agreement as of September 30, 2021 and live in different households in terms of resident records, the parent who lives with the child may preferentially receive the benefit. In this case, please attach a document confirming that a divorce by agreement is underway, etc. (e.g., a transcript of content-certified mail concerning an application for divorce by agreement, a photocopy of a writ of summons notifying the date of the first conciliation, a certificate of pendency of a case at a family court, a certificate of unsuccessful conciliation) to the application form.
- Q2. A high school student lives alone in Yokkaichi City to go to high school in the city. Parents live in a different city and pay living expenses for the student (child). Which city pays the benefit for the student?
- A2. The benefit is paid by the city in which the guardian (main income earner) (not the student) lives as of September 30, 2021. The method of payment and necessity to apply vary depending on the local government. Please contact the municipality where the guardian is domiciled as of September 30, 2021.
- Q3. A high school student lives alone outside Yokkaichi City. How should an application be made?
- A3. If the guardian (main income earner) lived in Yokkaichi City as of September 30, 2021, an application should be made to the City of Yokkaichi. In this case, please attach photocopies of resident records of all household members, including the child, to the application form.
- Q4. I am a public employee, and am raising a child who meets the conditions. I received child allowance for September 2021 from the office with which I am affiliated. Do I need to submit a certificate?
- A4. The City of Yokkaichi requires applicants to declare that they received child allowance for September 2021 in a designated field in the application form. This substitutes for the certificate from the office with which you are affiliated. Thus, it is not necessary to attach a certificate.
